#### 1. What is the purpose of the US Capitol Building?

Answer: To serve Congress, preserve history, and sustain the home of American democracy.

#### 2. What government institutions does the Capitol house?

Answer: House of Representatives and Senate

#### 3. What does the Capitol building symbolize?

Answer: It symbolizes freedom and is a monument to the spirit and resilience of the American people and their democracy.

#### 4. When did construction on the Capitol begin?

Answer: 1793

#### 5. Who was the first Architect of the Capitol (AOC)?

Answer: Dr. William Thornton, winner of the design competition for the new Capitol building.

**6. What were the challenges in building the Capitol?**

*Answer: Primary challenges were in acquiring materials and hard labor.*

**7. Construction was difficult. In 1803, Congress allocated funds to continue the construction process. Who was appointed as the architect?**

*Answer: Benjamin Henry Latrobe*

**8. In 1811, what was added to the Capitol and what was its purpose?**

*Answer: The second wing of the Capitol was added. Its purpose was so the House of Representatives could occupy its own legislative chamber.*

**9. What happened to the Capitol on August 24, 1814?**

*Answer: British troops set fire to the Capitol during the War of 1812.*

**10. After Charles Bulfinch was appointed as Architect of the Capitol, what parts of the Capitol were finished?**

*Answer: Chambers for the Senate and House of Representatives, Supreme Court building, and the Center Building.*

**11. Why did President Fillmore hold a competition to change the Capitol in 1850? How was it changed?**

*Answer: With the expansion in the number of states, there was no longer enough room for all Senators and Representatives.*

**12. Why was the dome changed in 1855? How was it changed?**

*Answer: The dome no longer suited the building's proportions since the president expanded significantly to the wings – so a cast iron dome replaced it.*

**13. What is the name of the statue on top of the Capitol?**

*Answer: Statue of Freedom*

**14. What is the “Apotheosis of Washington?”**

Answer: This is the name of the painting on the inside dome of the Capitol depicting George Washington as a god-like figure.

**15. What are the six groups of figures that line the perimeter of the canopy?**

Answer: War, Science, Marine, Commerce, Mechanics, Agriculture

**16. Continue to explore this site. Find three other facts about the Capitol building and list them below.**

Answers will vary, but some examples listed below:

- The cast iron dome was designed in 1854 by Thomas Walter, who also designed the north and south extensions.
- Walter was the fourth Architect of the Capitol.
- The fresco underwent a thorough cleaning and restoration from 1987 to 1988.
- The rotunda fresco was painted by Constantino Brumidi in 1865.
