

1. What action triggered the start of WWII? What year did this occur?

Answer: Nazi Germany invaded Poland in September of 1939.

2. What two major events happened in 1941?

Answer: The Germans invaded the Soviet Union (Russia) and the Japanese bombed Pearl Harbor, bringing the US into the war.

3. Who were the main countries that comprised the Axis and Allied Powers?

Answer: Axis Powers: Germany, Italy, and Japan; Allied Powers: Britain, USA, and the Soviet Union (Russia).

4. What was the "Final Solution"?

Answer: The Nazi plan to exterminate all Jewish people

5. What happened on D-Day?

Answer: Operation Overlord – the Allied Powers invaded Normandy, France.

6. When did the Germans surrender?

Answer: May of 1945

7. What happened in August of 1945 and how did Japan respond?

Answer: The Americans dropped an atomic bomb on Hiroshima, Japan. They surrendered on August 15, 1945.

8. Why was the memorial created?

Answer: To honor the Americans who helped fight World War II

9. How was the design chosen? Who was the creator of the memorial?

Answer: There was a contest. Architect Friedrich St. Florian's design was chosen.

10. Use what you have learned about the WWII Memorial to summarize the main elements of its design.

Answer: Answers may vary. The design consisted of the Rainbow Pool in a sunken plaza, surrounded in a circular pattern with 56 pillars which represent the unity of the U.S. states and territories during the war. There are two giant arches (each 41-feet tall) that represent the two fronts of the war.

Inside is the Freedom Wall covered with 4,000 gold stars, each representing one star for every 100 Americans that died during World War II. There is a sculpture placed in the middle of the Rainbow Pool and two fountains.
