Answer: James Hoban was selected in a contest. He won \$500.

Answer: October 13, 1792. Slaves were used.

Answer: John Adams

4. What happened to the White House during the War of 1812?

Answer: It was burned by the British

5. During reconstruction of the White House, what was added?

Answer: East and west terraces on the main building's flanks; a semicircular south portico and a colonnaded north portico.

6. It is said that the White House belongs to the people. Why is this true?

Answer: The President only stays there as long as the people want him/her there through elections. Once a new President is elected, the former President leaves the White House.

7. What were some of the major renovations made to the White House in the 1900s?

Answer: Under Teddy Roosevelt, the second-floor offices were converted to family living quarters. In 1902 the West Wing was constructed for more room for the presidential staff and more room for the president. The East Wing was constructed in 1942 for more office space. In 1948, the entire inner structure was rebuilt and a second-floor balcony was added. In the 1960s Jacqueline Kennedy collected and displayed items of artistic and historic value.
